Flushing: add antibiotic to gestation ration and full feed ten days before breeding.

Gestation: Feed approximately 4 lbs. to sows and 5 lbs. to gilts daily. Watch condition. Do not allow sows or gilts to become fat. Thirty days before farrowing increase feed so sows or gilts are fed a maximum of 6 lbs. per head, per day prior to farrowing.

#### Caution

CAUTION: Due to the copper level, do not feed to sheep. Follow label directions. The feeding of supplemental selenium should not exceed 0.3 ppm of total diet. The addition to feed of higher levels of this premix containing selenium is not permitted.
